- 2. The last date of submission of online application forms is **03 July 2021**, **17:00 hrs (IST)**. All eligibility criteria including age shall be determined as on the last date of the submission of online application forms. Age concession as per norms will be given to OBC, PwD and Ex-servicemen candidates.
- 3. For expeditious completion of the selection process, all communications in connection with the selection process will be undertaken only through electronic media and by way of announcements on IIT Palakkad website. Candidates are advised to mention their correct and active email address in the application, as all the correspondence like issuance of call letter or any other information will be communicated through email only.
